Cuprum metallicum (Copper)

Regions most affected:

Nerves, muscles, epigastrium, left side

Ailments from:

Suppressed symptoms or discharges, fright

Generals:

- Cramps and spasms
- · Twitching and jerking
- Convulsions start in fingers and toes
- Ailments associated with blueness and coldness of surface
- Metallic taste in the mouth

Mentals:

- Cramped, self critical, holding back on their thoughts
- Persecutory delusions
- Behaviour problems in children: destructive, spitting and biting
- **Alternating** moods timidity alternating with obstinacy

Modalities:

- < Emotions
- < Suppression of eruptions or discharges
- < Before periods
- < Hot weather
- < Touch
- > Cold drinks
- > Perspiration

Clinical uses:

Convulsions

- Cramping in any part of the body (start peripherally, extend upwards)
- Spasmodic asthma, whooping cough with laryngeal spasm
- Cholera with coldness and blueness of the skin and cramping pains
- Colic

Presenting complaint:

Left sided cramps, twitching, weakness and pain, following a stroke.

Doctor: How are things just now? Patient: Not too good, doctor.

Doctor: In what way?

Patient: This left leg - I'm getting less and less use of it.

Doctor: In what way?

Patient: Well, for instance, I can't go down the pavement

or up.

Doctor: Any twitchings or jumpings?

Patient: In my leg, sometimes, when I go to bed.

Doctor: Would you say that the weakness (of the leg) has

got worse?

Patient: Yes, I think so. I don't know why. I'm

continually tired, doctor, doing nothing.

Doctor: What about your concentration and your thinking?

How's that?

Patient: Fine thanks

Doctor: Do you have any stiffness, or not? Patient: A wee bit of stiffness in my legs, yes.

Doctor: Is that getting worse, or not?

Patient: [Heat] I can't take too much of...and cold, I can't

stand the cold.

Doctor: What happens in these situations?
Patient: Well if this arm gets cold it gets painful.

Doctor: Which arm?

Patient: The **left** arm.

Doctor: Do the **muscles go tight** in the leg?

Patient: A bit, yes.

Doctor: Does it start high up in the leg and go down, or

does it start low down and come up?

Patient: [It starts] low down and comes up.

Doctor: It was the twenty-ninth of July I saw you.

Patient: Yes, it was.

Doctor: How are things?

Doctor: In what way has that changed? Patient: Well, I never had them before. Doctor: What did you have before?

Patient: Nothing.

Doctor: Did you have any sensation in the arm at all?

Patient: No.

Doctor: Was it numb?

Patient: It wasn't numb...a couple of mornings I woke up

and I could feel these tinglings in my arm, and my

hand.

Doctor: Are these tinglings uncomfortable?

Patient: No.

Doctor: How long do they last?

Patient: Only for seconds. I was quite

pleased, actually, when I felt it.

Doctor: What about the twitching and jumping?

Patient: Oh, that's stopped... Of my leg you mean?...Yes.

Doctor: How are you feeling in yourself, generally?

Patient: Oh, I'm feeling a lot better, thank you, doctor. If

Ruta graveolens (Common Rue)

Affinity for **cartilage** and **ligaments**, particularly **where they attach to bone**

Useful where there is a tendency to **contracture**, **cramps** or **dislocation**

Associated with the large joints, **especially the knee** Pain feels as though bones were broken, and there is aching or a bruised sensation in the supporting ligaments and tendons.

Associated with **fatigue** and **aching**, particularly **after sprains** and strains. Indicated in repetitive strain injury, and of great value in **sports medicine**.

May be used topically following sprains.

Clinical Uses:

- Osteoarthritis of the knee
- Chondromalacia
- Osgood Schlatters disease
- Sport injuries to tendons and ligaments (collateral ligament sprains in skiing injuries of the knee)
- Growing pains
